


## Firm Commitment Volume, Staffing Challenges FY13 to FYTD22








## Firm Commitment Volume by Program FY17 to FYTD22







## Application Queue Update



Queue implemented in Oct 2020, peaked in spring 2021 (2020 MAP Guide effective date)

240 applications currently in-processing: 212 by HUD (full internal capacity w/ WLS) + 28 by contractor (Nuvo Sum)

64 applications currently in the queue (in 2 Regions)





## Underwriting & Closing Support Services Contract Update

- 12-month contract awarded to NuvoSum in Dec 2021; provides loan underwriting and/or closing support services through Dec 2022: up to 300 223(f)s + 200 223(a)(7)s
- 161 applications (primarily 223(f)s) assigned to NuvoSum since Jan 2022 (4 of 5 MF Regions have utilized); 122 firm commitments have been issued so far, and 35 loans have closed utilizing NuvoSum's closing support services
- HUD staff must complete ENV review/HEROS and other specific tasks for all applications assigned to contractor
- Competitive 5-year contract procurement is underway; goal is for long-term contract to be awarded when current 12-month contract expires in Dec 2022













## West Region News



- Year-over-year, we've doubled application assignments.
- We're continuing to update applications in the queue.








### West Region Firm Commitments Issued

In FY22, 223(f)s were, once again, an overwhelming portion of our business.








### West Region Workload Share: Nuvo Sum

NuvoSum has only been issuing Firms for 6 months






#### Firms Issued: Affordable & Market Rate

Firms for Affordable deals in FY22 are expected to be up <u>17%</u> over FY21.

Firms have been issued on 4,800 affordable units, FYTD.





Firms issued on 30 LIHTC developments, totaling 2,276 units!



2,522 assisted units preserved!






## Workload Share: Other Regions

WLS BC screens applications for potential WLS.

Deficiencies cured; any updates are made.



WLS BC drafts request and summary of application, sends to HQ.

Headquarters sends request to other regions.

Regions review request and summary and determine if they have <u>capacity</u> and <u>appropriate staffing</u>.

If they do, they accept, and you are assigned an UW!

**Key:** Any application can be workload shared, but a region must have the capacity and appropriate staff.





## West Region: Closings

The West closed on \$3.5 billion in FHA Insurance FYTD, representing 16,958 units.

FYTD, we've closed on 4,667 units of affordable housing.







Endorsed 1,322 Units of LIHTC NC/SR





## West Region: Unification

#### Regardless of HUD office, we are now:

- Assigning Applications to Underwriters and Tech Staff
  - Applications no longer sit in queue waiting for qualified staff in the application's "office"
- Balancing Staff amongst Supervisors
- Training and mentoring staff

#### What this doesn't mean:

• We ignore the benefits of having two offices

#### Where possible:

• Local staff will be assigned to local transactions and complete site visits







## Climate Change



- 1. After December 1, all NC/SR applications with an EA-le vel re vie w must consider all *reasonably* foreseeable climate impacts.
- 2. Depending on the climate, we might expect the below to be considered:
  - Excessive Heat Flooding

- Harsh Winters Power Outages
- Wild fire s

- Drought
- 3. These risks should be mitigated via appropriate means.

Applications in the Queue Do Not Need to Update their Environmental Review!





## Direct-to-Firm Applications

#### Nationally:

- 1. The Direct-to-Firm submission option for §221(d)(4) applications has been extended through March 31, 2023.
- 2. If there are no complex environmental issues, those with:
  - Pre-applications in the queue may convert to a Firm App.
  - Existing encouragement letters may submit Direct-to-Firm.
- 3. If the application is rejected, the application fee will be considered earned.

#### In the West:

- 1. Lenders may submit a Direct-to-Firm Application, at their own risk, for applications which did not have existing encouragement letters when the memo was issued.
- 2. We may choose to encourage a Pre-Application at concept.
